Chief Allen reported Grandview officers responded to 234 calls in August and Sangamon County was called to assist 54 times in the Village. Total calls for the year is 2176. All officers are in compliance with mandated ILETSBE training. He took Officers Kennedy and McPherson for weapon qualification and will be taking Officer Sutton for qualification on Friday. The 2023 Ford has been getting regular oil changes about every three months. This frequency is because of the hours the vehicle is running, not the milage. Alier License is due next month, which is a \$500 annual fee. The new body cams have been ordered and are expected to arrive around November 1. President Ray reported there is an ILETSBE Grant the Village can apply for to receive reimbursement.
