VILLAGE IMPROVEMENT, ZONING, PERMITS - TRUSTEE CARRIE CHAPMAN

Reminded the board that the dates for the Village Garage Sales are going to be Friday, May 31, 2024 and Saturday, June 1, 2024. The clean-up days will be Saturday, June 8, 2024 for the south side of the village and all of North Grand and Saturday, June 15, 2024 for the streets on the north side of the village.

EQUIPMENT, STREETS, INFRASTRUCTURE, MFT/RBI - TRUSTEE GARY NATION

Trustee Nation reported he talked to the tenants at 2240 E. Converse about the tree and was told they would have their landlord contact the Village about whether or not they want the tree removed. He has not contacted the other residents yet.

President Ray reported more details of her meeting with Senator Turner, Representative Coffey, and Kevin Kuhn. She and Kevin Kuhn were asked to prioritize the road repairs, starting with the worst ones and put them into groups. She also gave the board some more information about the lobbyist she would like the Village to hire.

Trustee Chapman made a motion to hire Josh Witkowski as a lobbyist for the Village with a 1 year contract, with an option to withdraw at 6 months. Trustee Nation seconds the motion.

Bob West is still working with Petersburg on the water main replacement on Wolfe and getting bids for potholing.

POLICE AND NEIGHBORHOOD WATCH - TRUSTEE DIANA JARRETT

Trustee Jarrett wants to get started on lettering on the squad cars. Chief Allen said he will get some bids.

Chief Allen also reported the officers have had approximately 1300 dispatch tickets since the first of the year.

The new cameras and alarm system installation has started. The transmission in the 2016 Explorer needs replaced. The cost would be about \$5000.00. He would like to get another 2016 Explorer and just transfer the equipment. He has found one that he is waiting for more information about. He is still interested in the FLOCK Security Cameras. He has a couple of candidates that he would like to interview. He will contact them to meet with President Ray, Trustee Jarrett and himself. He is working on cleaning up the ordinance for tow fees and tow releases, but has some concerns about officers collecting the fees when the office isn't open.

OLD BUSINESS

There was discussion about the start and end dates for summer maintenance employee Ethan S.

Trustee Chapman made a motion to for Ethan S. start date to be June 3, 2024 and end date August 16, 2024. Trustee Bell seconds the motion.

Chief Allen reported he was approached about Village officers working off-duty employment. The current policy in the handbook prohibits the officers using village equipment for outside employment. He is looking into changing the policy to allow them to use their village equipment for outside employment.
