Bids were received from MB Heating & Cooling and Rich Gatschenberger to replace the heater. President Ray is going to contact one other person to check the heater.

Chief Harton presented the bid to purchase a new fully equipped squad from Morrow Brothers for a cost of \$54,359.00.
